Myles served as a Patrol Lieutenant (Watch Commander) at the Carter County Sheriff's Office, Tennessee. He worked in various positions to include Patrol, Corrections, Narcotics Investigations, SWAT, Federal Task Force Officer Federal Bureau of Investigation & United States Marshal Service Task Force. He has 5 years' experience as an Adjunct Instructor for East Tennessee State University Department of Criminal Justice & Criminology. Myles received Master of Arts in Criminal Justice, East Tennessee State University (2011). Beginning in 2019, he helped develop and served as Lead Criminal Justice Instructor at the Tennessee College of Applied Technology – Elizabethton, an 864-hour Law Enforcement/Corrections training program that has received recognition, certifications, and training partnerships with local, state, and national agencies. In 2022 This program was chosen by the Governor's office and TBR to be implemented across 12 TCATS and all Community Colleges in Tennessee.
